Why a peacebuilding & fragility portfolio in MANGO ?

- SDC is deeply concerned with fragile and conflict-affected contexts that **increasingly concentrate the extremely poor people** in the world.
- While working on its own approach to fragility, SDC has also a **strategic interest (scale and impact) in influencing the multilateral system's response** to fragile and conflict affected situations.
- The UN & MDB section is currently working on four **entry points** selected according to (a) their potential to ultimately reach the largest number of **beneficiaries**, and (b) the **added-value** and potential leverage that SDC/Switzerland has, based on its expertise and experience.
- These entry points are the **UN system**, the **World Bank Group**, **SDG16** and the **private sector**.

Private sector

Support a peace-positive engagement of the private sector.

UN

Support a more effective and preventive work of the UN system on peacebuilding and fragility.

UN-WB

Improve the collaboration between UN and WB in fragile contexts.

WB

Support a stronger engagement of the WB (and other IFIs) on peacebuilding and fragility.

SDG 16

Create a more conducive political environment for progress on peace, justice and inclusion, at the global, national and local level.

What's in the portfolio? 4 programmes

(as of March 2023)

UNDP – Prevention Agenda *Budget: 1 mio. CHF / year*

Duration: 2022-2024 (phase 7)

1. **UNDP – DPPA Joint Programme:** Deploy Peace and Development Advisors (PDA) to Resident Coordinators Offices (RCO) in fragile contexts. PDAs support RCO, but also the UN Country Team and the host government with conflict analysis and with advises on sustaining peace.

Multilateral Peacebuilding *Budget: 3 mio. CHF / year **

Duration: 2021-2023 (phase 0+1)

4. **UN Peace Building Fund:** Contribute to the main United Nations fund working on peacebuilding and sustaining peace (ref. Twin resolutions). The Peace Building Fund (PBF) includes a facility to support the «WB-UN Partnership in fragile contexts».
5. **WB State and Peacebuilding Fund:** Contribute to the main trust fund of the World Bank working on fragility and prevention. The State and Peacebuilding Fund (SPF) is pushing the frontiers of the WB on fragility & conflict. The SPF is also in charge of the «WB-UN Partnership».

SDG 16 Initiatives

*Budget: 1.1 mio. CHF / year ***

Duration: 2021-2023 (phase 3)

6. **Pathfinders:** Contribute to Pathfinders' mission to create a global movement to promote peaceful, just and inclusive societies for sustainable development. Focus on (a) national implementation of SDG16, and (b) a global dialogue on Violence Reduction.
7. **Transparency Accountability and Partnership Network (TAP):** Contribute to TAP's global network of 200+ civil society organizations, supporting their engagement involvement in national implementation and reporting on SDG16.

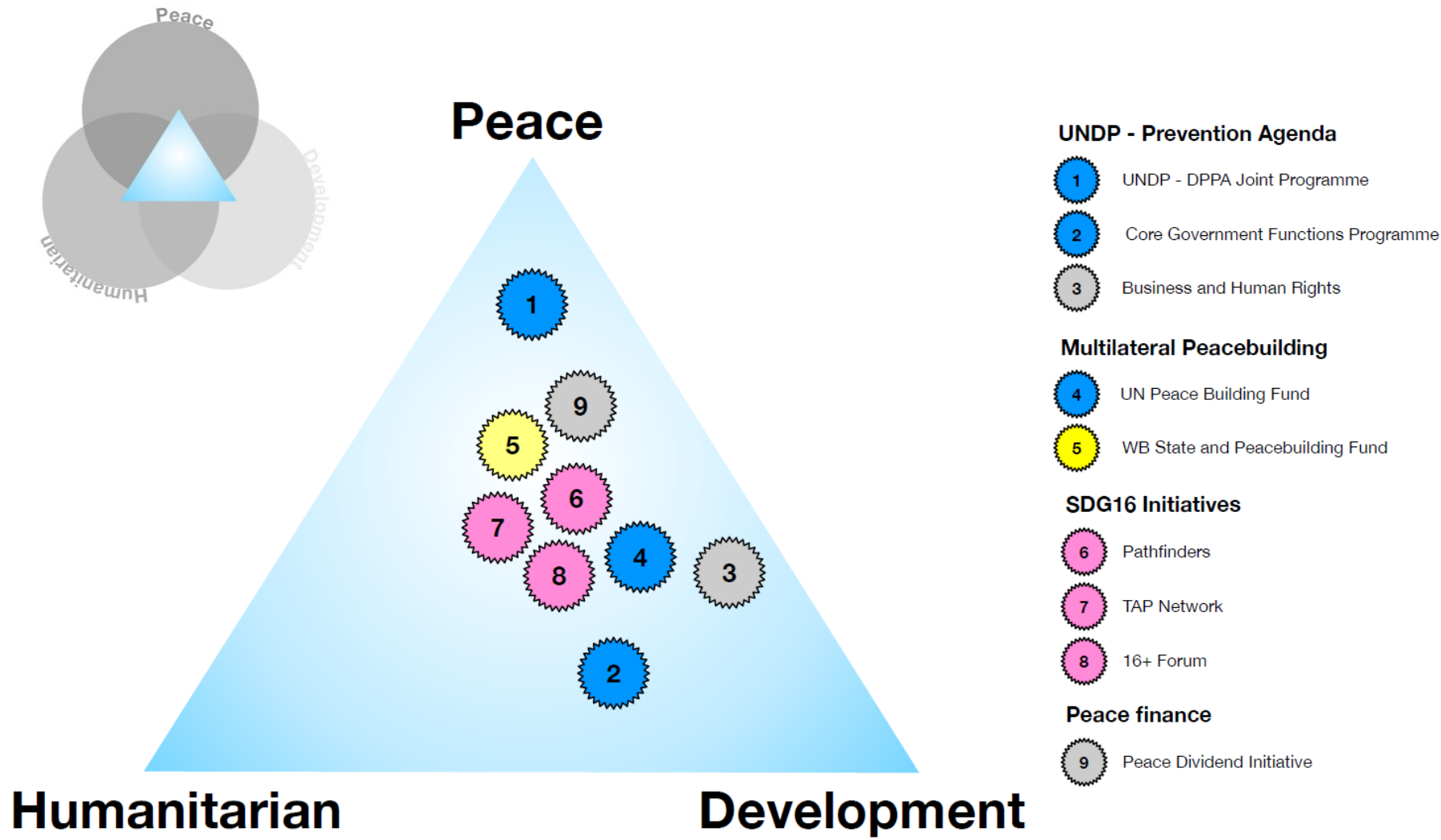
Peace finance

*Budget: 0.5 mio. CHF / year ****

Duration: 2023-2026 (single phase)

9. **Peace Dividend Initiative (PDI):** Recently established Geneva foundation aiming at harnessing market forces for peace, by leveraging global capital and prepare peace-positive investment opportunities in fragile and post-conflict contexts. Its unique selling proposal = working with peace mediators (e.g. HD Centre)

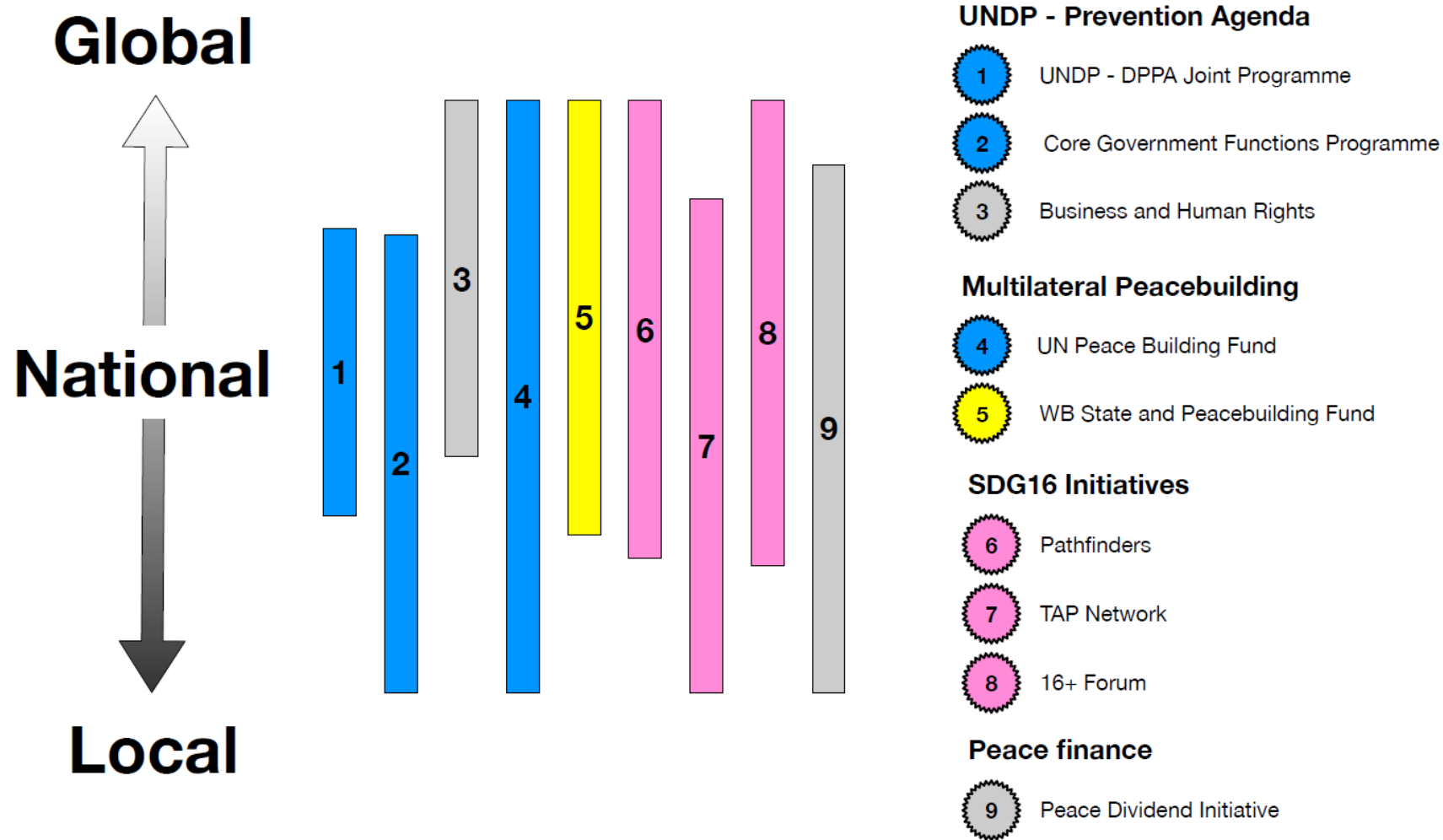
All projects work **in and on the triple nexus**



All projects of the portfolio work at the crossing of **humanitarian, development and peace** sectors, the so-called **HDP** or **triple nexus**.

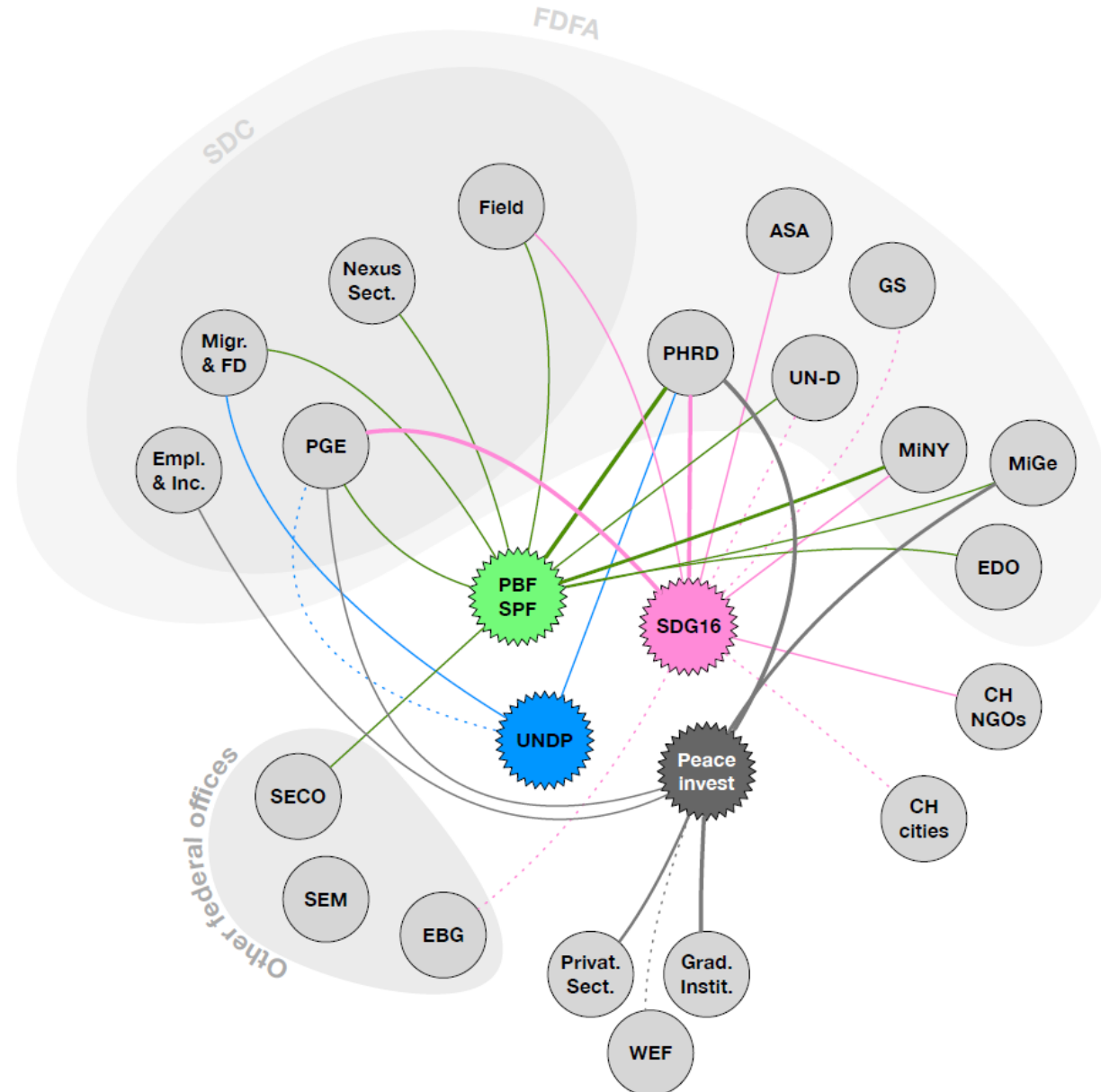
One can see this in the kind of activities that these projects support in the field, the diverse partnerships they establish, the objectives they have, etc.

All projects aim at **connecting global and local level**



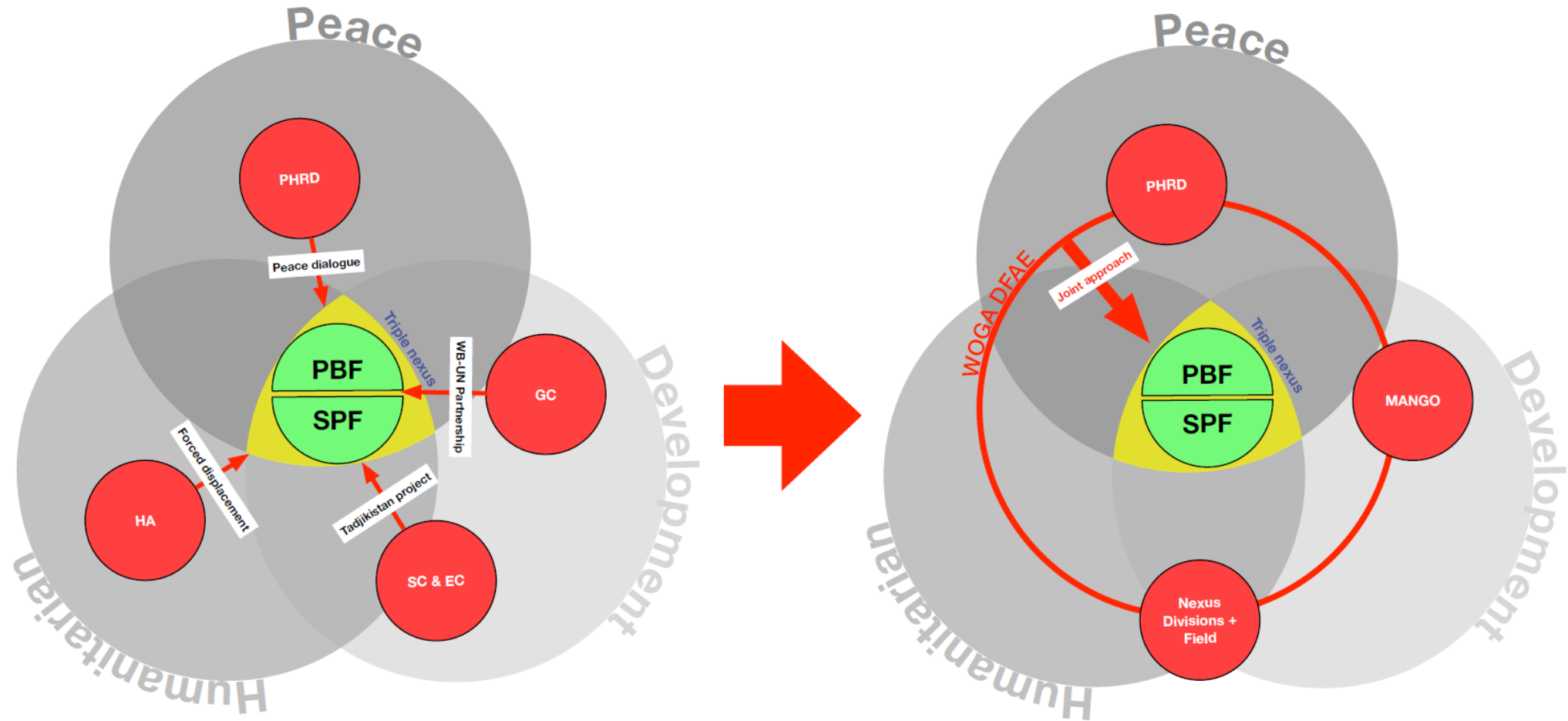
The fragility portfolio **spans through different levels of intervention** and fosters their connection: field-anchored global processes, national delivery of global commitments, etc. Switzerland is working on **bridging the gap** between these levels.

All projects are **anchored in a WOGA approach**



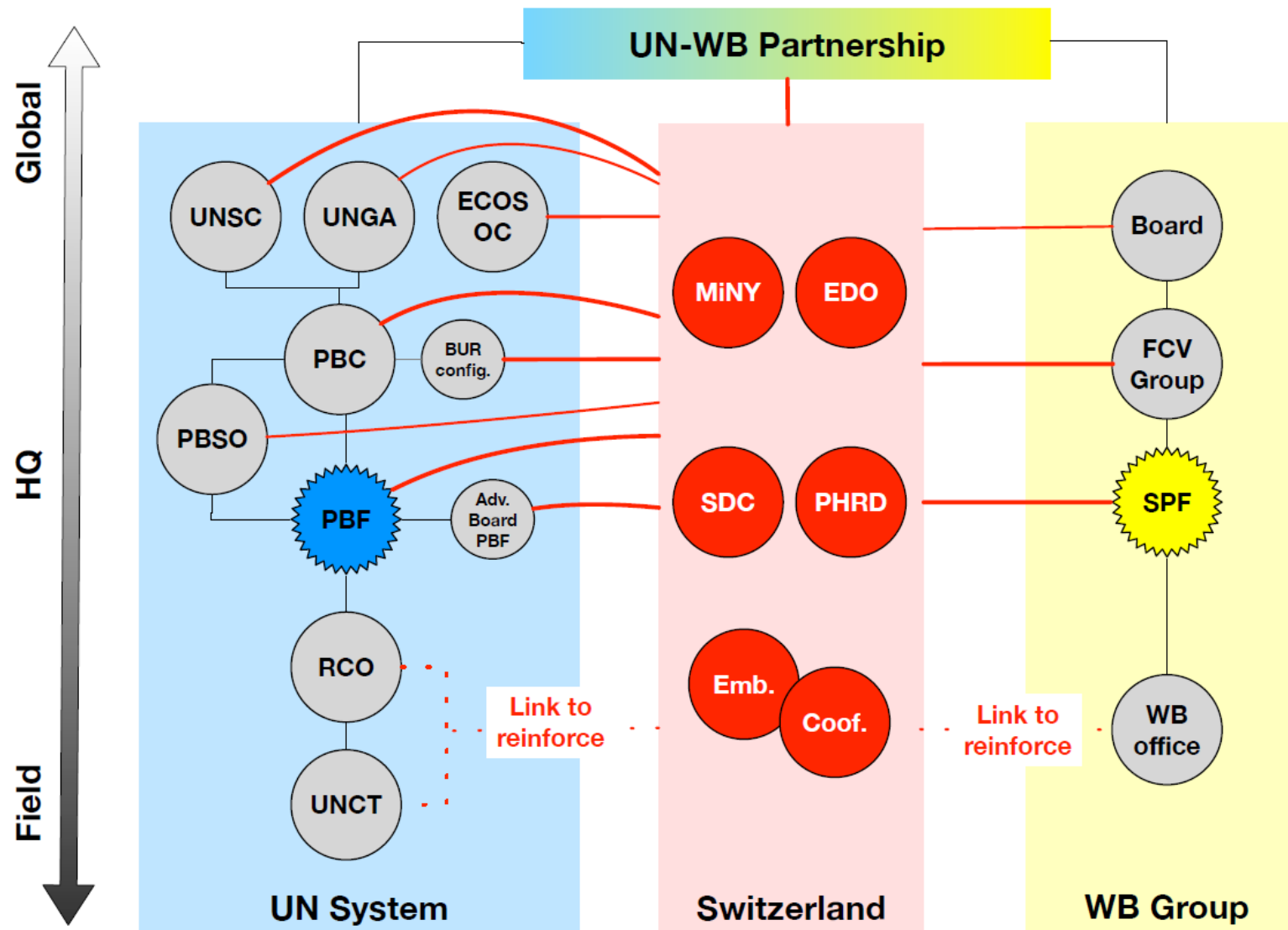
Different units within and beyond the FDFA are concerned with MANGO's PB & fragility portfolio. For these programmes to work and deliver their expected outcomes, this **network approach is a requirement**. In order to support the triple nexus approach of its multilateral partners, **Switzerland itself has to work in a nexus way**.

Flagship programme: Multilateral peacebuilding (1/2)



Different FDFA's units are interested in the UN Peace Building Fund (PBF) and the WB State and Peacebuilding Fund (SPF). In the past, these two funds have received supports from these units, without particular internal coordination. Since 2021, a **joint approach for the whole FDFA** was launched to guide Switzerland's policy dialogue and support to the two funds. The engagement of FDFA's field representations is key for this joint approach.

At the **global level**, Switzerland is highly committed to the peacebuilding (sustaining peace) agenda and the HDP Nexus. It has therefore adopted a very **comprehensive policy influencing approach** at the HQ and MiNY/EDO levels.

At the **field level** the Swiss approach on influencing the multilateral actors becomes **less structured and systematic**.
