UNITED NATIONS HIGH COMMISSIONER FOR REFUGEES (UNHCR)

UNHCR is mandated by the United Nations to protect and safeguard the rights of refugees and seek permanent solutions that allow them to rebuild their lives. It supports refugees who return to their country, people displaced within their country, as well as stateless people.

Governance

UNHCR is governed by the UN General Assembly and the Economic and Social Council (ECOSOC). Standing Committee meetings are held three times a year and serve to prepare the annual Executive Committee meeting, which consists of 110 members and approves the agency's budget.

Strategic Objectives

UNHCR's Strategic Directions 2022-2026 commit UNHCR to:

- Respond rapidly and effectively in emergencies and beyond;
- Promote the inclusion of refugees, displaced and stateless people in economic growth and poverty reduction efforts;
- Empower the people to determine and build their futures;
- Pursue solutions to address the consequences of displacement and problems of statelessness.

UNHCR's support to the Global Compact on Refugees (GCR) directly contributes to UNHCR's strategic objective towards enhancing refugees' self-reliance and pursuing durable solutions.

Added Value and Challenges

As the custodian of the Refugee Conventions, UNHCR has the specific mandate from the United Nations to protect the rights of refugees worldwide. It also has specialised staff with a vast experience as well as the capacity to respond rapidly to forceful displacement in emergencies.

The challenges of forced displacement have grown in scope, scale and complexity due to intractable conflicts, and the climate crisis. The protection space has diminished, inequalities have increased. Displacements have become more complex, including mixed movements of refugees, internally displaced people and migrants.

Key Results in 2023

19.3 million people, including 7 million children, received protection services. 7.3 million people received cash assistance and 8.1 million non-food items to address their basic needs. 14.6 million people received essential health services and 1.5 million women and girls were provided with sexual and reproductive health services. 2.9 million people received shelter and housing assistance.





SWITZERLAND'S PARTNERSHIP WITH UNHCR

Switzerland's Strategic Priorities

- Centrality of Protection: Switzerland wants UNHCR to improve protection environments for refugees and other people of concern.
- Locally-led action: Switzerland encourages UNHCR to reinforce its localisation efforts, with focus on the engagement and inclusion of refugees and other people of concern in response planning and implementation.
- Climate-related migration: Switzerland wants UNHCR to mitigate climate-related displacement.
- Durable solutions: Switzerland supports UNHCR to provide durable solutions for refugees and other people of concern to address the effects of displacement.
- Governance and quality funding: Switzerland holds UNHCR accountable and supports its qualitative resource mobilisation efforts.

Cooperation at Country Level

Switzerland provides country or regionally earmarked contributions to implement UNHCR's programmes and, in case of emergencies, contributions from SDC's emergency relief fund. Through the secondment of Swiss experts (e.g. protection, shelter, water and sanitation, cash) UNHCR increases its protection emergency response capacity and its ability to facilitate durable solutions. Switzerland also supports the work on durable solutions through the IDP Solutions Fund. Swiss Cooperation Teams exchange regularly with UNHCR country offices on the challenges they face at country level and cooperate in their policy dialogue with national or subnational authorities.

Cooperation at Global Level

Switzerland supports the Global Protection Cluster as well as activities against Gender-Based Violence and for Education in Emergencies. The Geneva Technical Hub promotes environmental sustainability of refugee camps and settlements. The Digital Hub on Treasury Solutions works on efficient financial transactions including a more rapid and targeted cash assistance. Switzerland co-hosts the Global Refugee Forum and co-sponsors the Nansen Award to support resource mobilisation. The State Secretariate for Migration (SEM) supports resettlement activities and FDFA's Peace and Human Rights Division (PHRD) is engaged against human trafficking. At policy level, Switzerland is part of the UNHCR Standing and Executive Committee.




